Dear Mr. Davis:

This letter provides you the final results of our significance determination of the preliminary Greater-than-Green finding identified in our letter to you dated October 15, 2010, which included the subject inspection report. This Greater-than-Green finding was discussed in detail in Section 3.26.1 of the subject inspection report.

At your request, a Regulatory Conference was held on December 6, 2010, to further discuss your views on this issue. During the meeting, your staff described your assessment of the significance of the finding, the corrective actions taken to resolve it, including the root cause of the finding.

After considering the information developed during the inspection and the information you provided at the conference, the U.S. Nuclear Regulatory Commission (NRC) has concluded that the inspection finding is appropriately characterized as a Greater-than-Green finding (i.e., a finding having more than very low security significance).

You have 30 calendar days from the date of this letter to appeal the staff's determination of significance for the identified Greater-than-Green finding. Such appeals will be considered to have merit only if they meet the criteria given in the NRC Inspection Manual Chapter 0609, Attachment 2.
