On May 5, 2011, the U.S. Nuclear Regulatory Commission (NRC) completed a supplemental inspection pursuant to Inspection Procedure 95001 at your James A. FitzPatrick Nuclear Power Plant to follow up on previous security inspection findings. The enclosed inspection report documents the inspection results, which were discussed at the exit meeting on May 5, 2011, with you and other members of your staff. The NRC was informed of your readiness for the inspection on February 3, 2011.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

As a result of this inspection, no findings were identified.
